 - **Entry Fee:** None
 - **Arrival Time:** Friday, June 20 after 5:00 p.m. Mandatory meeting of all contestants at 5:30 p.m. at the stage area.
 - **Judging:** Friday, June 20 at 6:30 p.m. American System of Judging. Honorable Mention Ribbons may be awarded in each class.
- ** There will be a preliminary judging to pre-qualify dogs. The Judge's decision is FINAL. If the dog does not pre-qualify, the handler will be asked to remove the dog from the property immediately.**
- Entrants must bring their own **pooper-scooper** and **water dish**.
 - Contestants with dogs will be admitted free to the Fair. (All other family members and friends must pay admission)
 - Contestants are not allowed to wear any clothing or accessories to promote any organization or business.
