TRAILER OR CAMPER SPACE APPLICATION

Space is for the convenience of our exhibitors. A plot plan has been established and all spaces are on a first come, first served basis. **Each exhibitor may ONLY bring in two trailer space applications (counting their own) on opening day.** SPACE IS AVAILABLE ONLY FOR THOSE EXHIBITORS SHOWING LIVESTOCK. THE FEE FOR A PERMIT IS **\$50.00**. Applications for trailer space **need not** be accompanied with livestock entries and entry fees. However, if no entries are received by Friday, May 16th at 5:00 p.m.; said trailer space and fees paid will be forfeited. **Trailers will be permitted on the fairgrounds after 4:00 p.m. on Tuesday, June 21, 2016.**

Be sure you park in your designated space within the lines and parallel to other trailers. No horseshoe, T shape, or perpendicular configurations: all trailers must be in line with others. Once positioned, you cannot move to another spot. No water or electricity is available nor may any be used. All drain outlets must be capped. Portable generators are **NOT** permitted. Throwing wash water or refuse from trailers or campers is prohibited. Refuse cans will be provided for your use. A good housekeeping program shall be maintained throughout the day. **No vehicles are allowed to park in the trailer area.**

During Fair there are licensed (issued by the Alcoholic Beverage Commission) concessionaires to sell alcoholic beverages. **Therefore, it is illegal for anyone to bring any alcohol onto the fairgrounds (beer, wine, etc.).** Violators are subject to fine and/or arrest. Any illegal act will be reported to the police. If the police have to be called in, the prevailing rate per hour will be charged to the offender.

EXHIBITORS STAYING IN TRAILERS MUST HAVE AN ADULT GUARDIAN OR ADULT CHAPERONE!

Special safety procedures shall be developed in conjunction with the State Fire Marshall and approved before barbecuing at the individual vehicle parking spaces is permitted. Any violation of the above rules will result in immediate removal of trailer.

LIVESTOCK TRAILER LOT AND PARKING LOT RULES & REGULATIONS

- 1) The Livestock Exhibitor Trailer Park will have a midnight curfew. All people staying in the trailers will have to be in their trailers and all guests must leave the fairgrounds by midnight.
- 2) The Pit Parking Area (by the track) will be locked at midnight. All vehicles must be removed from that area by this time, or they will be locked in the Pit.
- 3) If there is not an adult at each campsite, the exhibitor's parents will be called to come and pick up their child. Families who do not have an adult in their trailer will forfeit the opportunity to have a trailer space at the Fair in the future.
- 4) The management and Board of Directors reserves the right to remove an exhibitor and/or exhibits from the fairgrounds for behavior deemed disruptive, e.g. alcohol, drugs (use or possession), smoking in barns, defacing property, etc. Award money may be withheld. Anyone on grounds is subject to search by security.
- 5) **Only** livestock exhibitors, parents or guardians tending to animals will be allowed in the barn area after 10 p.m. **NO SLEEPING IN BARNs.**
- 6) Trailers will be released on Sunday, June 26, 2016 any time after 10:00am. No tack or animals are to leave at this time.
