CEO Hubacker shared examples of some of the complaints received and the negative response from City of Petaluma officials such as the Mayor calling for complaints to be directed at CEO Hubacker. CEO Hubacker reported steps taken by meeting with Petaluma Police Officials as well as

the City compliance team; both of whom were helpful in forming solutions. CEO Hubacker reported that the new policies would restrict Sunday events to an 8:30pm time limit which is well within the 10pm City of Petaluma Sound Ordinance. CEO Hubacker reported that while

Compliance Officer Hearn said they could have sound up to 85-90Dba the

fairgrounds would hold themselves to a stricter standard 5-

10Dba below the City Ordinance. Director Benedetti suggested a follow up letter to the City of Petaluma officials regarding their response. Director Ghirardelli volunteered to start a draft letter. President Moore additionally offered to attend public comment at the next City of

Petaluma council meeting.
