OLD BUSINESS: A. 2024 Sonoma-Marin Fair Logo – M/s/c Directors McClure and Ghirardelli moved to approve

the 2024 Sonoma-Marin Fair logo as presented. The motion passed unanimously.

NEW BUSINESS: A. Western Fairs Association Convention. CEO Tesconi reported the 2024 convention will take

place in Anaheim, CA, on January 3-6, 2024. No action was taken.

B. Long-Range Planning- The Board of Directors discussed ideas and changes to the 2024 Sonoma-Marin Fair. Direction was provided as outlined below but no action was taken.

<u>Fair Dates</u> – It was discussed to move the fair from a 5-day to a 4-day fair – Thursday, June 20th through June 23rd- to change the opening time on Thursday to 3 pm and keep the remaining days at a Noon open time.

<u>World's Ugliest Dog Contest</u> – It was discussed to move the World's Ugliest Dog Contest to the main stage on Thursday.

<u>Parking</u> – It was discussed to increase the parking to \$10.00 and to include VIP parking at \$15.00

<u>Vendors</u> – It was discussed to decrease the price of inside vendor spaces by \$100 and to increase the outdoor vendor spaces. It was also discussed to reduce the number of vendors on the poles and to create a more vigorous list of requirements/restrictions for outdoor vendors.

<u>Admission</u> – It was discussed to change the price of admission for seniors to \$14.00 and to change senior day to Thursday, allowing seniors free admission until 6 PM

<u>Entertainment</u> – It was discussed to have country music concerts on Friday and Saturday nights and continue with Fiesta Latina on Sunday night.

<u>Exhibits Department</u> - Potential exhibit department changes were discussed and sent to the Exhibits Committee for further review and discussion.

<u>Alcohol Policy</u> – It was discussed to add spirits to the liquor license.
