#### **Schedules**

It is the suggestion of the committee to leave the 2024 Livestock Show Schedule the same as 2023 It is the suggestion of the committee to make adjustments to the stills drop-off schedule to reflect the possibility of moving to a 4-day schedule. Suggestions are reflected in the attached schedule.

## **Jr Stills Premiums and Entry Fees**

It is the suggestion of the committee to do away with entry fees for the youth stills department and eliminate the class premiums, and offer greater awards/prizes for the Best of Shows/Division in each department.

## **Youth Focus**

It is the suggestion of the committee to combine the Youth Focus classes into the "regular" Guidebook divisions and to add a sweepstake award to those classes that have historically been entered as Youth Focus.

## Award Sponsorship

It is the suggestion of the committee to increase the base donor level from \$50 to \$65 to cover the increase in the cost of plaques and banners.

#### **Horse Show**

Mandy Clendenen will meet with the Petaluma Riding and Driving Club Board of Directors to determine a date for the Sonoma-Marin Fair Open Youth Horse Show.

## **Guidebook/Rule Changes**

It is the suggestion of the committee to make the following changes and/or deletions to Local Rules and the 2024 Guidebook.

- Add commercial heifers to the weigh-in schedule and note the addition in the corresponding department.
- Add to Local Rules under eligibility Any exhibitor under the age of 9 who has entered into a
  livestock class they are ineligible for will be moved to the special junior class associated with that
  species if available.
- Add Those individuals receiving an Open Junior Classic award must be in show attire in order to receive their award.
- Add to local rules Show attire for the Open Junior Classic Shows will consist of closed-toed shoes, long pants, and a dress shirt.
- Remove Local Rule/Livestock/C Registration Papers must be checked in prior to Tuesday, June 18, 2024.

# 2024 Sonoma-Marin Fair Excerpt From Long-Range Planning Session During November 15, 2023, Board Meeting

**Fair Dates** - It was discussed to move the fair from a 5-day to a 4-day fair - Thursday, June 20<sup>th</sup> through June 23<sup>rd</sup>- to change the opening time on Thursday to 3 pm and keep the remaining days at a Noon open time.

<u>World's Ugliest Dog Contest</u> - It was discussed to move the World's Ugliest Dog Contest to the main stage on Thursday.

Parking - It was discussed to increase the parking to \$10.00 and to include VIP parking at \$15.00

**Vendors** - It was discussed to decrease the price of inside vendor spaces by \$100 and to increase the outdoor vendor spaces. It was also discussed to reduce the number of vendors on the poles and to create a more vigorous list of requirements/restrictions for outdoor vendors.

<u>Admission</u> - It was discussed to change the price of admission for seniors to \$14.00 and to change senior day to Thursday, allowing seniors free admission until 6 PM

**Entertainment** - It was discussed to have country music concerts on Friday and Saturday nights and continue with Fiesta Latina on Sunday night.

**Exhibits Department** - Potential exhibit department changes were discussed and sent to the Exhibits Committee for further review and discussion.

<u>Alcohol Policy</u> - It was discussed to add spirits to the liquor license.
