Re: 2024 World's Ugliest Dog® Contest – Friday, June 21, 2024

This year, the 2024 Sonoma-Marin Fair begins on Thursday, June 20th, and runs through Sunday, June 23rd.

Of course, one of our crowd-favorite events is the "World's Ugliest Dog® Contest." We are looking forward to another wonderful pageant of pups, and want to remind you of important points about this contest:

- All dogs will be entered into one large class, rather than being separated by pedigree or mutt.
- We will have the Grand Prize of \$1,500 for first place, as well as second-place and third-place trophies and cash awards.
- We will have a special "Spirit Award" which will be based in part on your dog's biography that you submit with your entry.
- We will have the "People's Choice" award, selected by visitors to our website who vote for their favorite pooch.
- We are charging a nominal entry fee of \$10.00 per dog after May 17, 2024. Entries before May 17, 2024, will be free. You receive full admission to the fair, and each dog will receive a special gift for being a contestant!
- We have a closing date of Monday, June 17th for <u>all</u> entries. This means your paperwork needs to be **in** the office by that date. This will allow staff to better prepare the programming for the contest.

Included is your Rules and Regulations Sheet, as well as an Entry Form. Please fill it out and return it to our office along with a picture of your dog, proof of rabies vaccination, and biography. If you prefer, you can send your entry paperwork via email to: entryoffice@sonoma-marinfair.org. Regardless of entry method, please send a high-quality digital (.jpg) photo of your dog to include on our website for the "People's Choice" award voting.

We will be sending updates to all participants with details of the contest as we get closer to the fair's opening.

### PRIZES

First Place:	\$1,500 & Trophy to the World's Ugliest Dog®
Second Place:	\$1000.00 & Trophy
Third Place:	\$500.00 & Trophy
Special Awards:	"Spirit Award" (determined by dog's biography and selected by award sponsor): The World's Ugliest Dog <sup>®</sup> Spirit Award will honor a dog and owner who have overcome obstacles and/or are providing service to the community based on the dog's biography. Examples of this are: raising awareness for dog rescue and adoption, visiting nursing homes or hospitals, participating in reading time at the library, etc.
	"People's Choice Award" (determined by public vote, received online): The public will have the opportunity to view the dogs' photos and biographies on our website and vote for their favorite. The winner will be announced on stage at the contest.

### RULES

- 1. All dogs must pass vet check before being allowed onto the grounds. If the dog does not pass vet check, the handler will be asked to remove the dog from the property.
- 2. No animal that shows evidence of any active, communicable disease shall be admitted or allowed to remain on the grounds.
- 3. No animal from any premises under quarantine for disease shall be admitted or allowed to remain on the grounds.
- 4. Contestants/owners/handlers must bring their own pooper-scooper and water dish.
- 5. Contestants and owners/handlers are not allowed to wear any clothing or accessories to promote any organization or business.
- 6. Any inhumane or other inappropriate action to animals by the contestant may result in disqualification, forfeiture of awards, and removal of the contestant and dog from the fairgrounds.
- 7. Animal must not have been intentionally altered to enhance appearance for the purpose of this contest.
- 8. Animal health decisions will be made in the best interest of the animal and other animals at the fair.
- 9. Management reserves the right to require health inspections and/or diagnostic tests before, during, or after animals are admitted to the fairgrounds and to implement disease control procedures as deemed necessary.
- 10. Determinations made by the official veterinarian and/or judges shall be final and cannot be protested. No refunds will be made.
- 11. Contestants must comply with all state and federal animal health regulations and Sonoma-Marin Fair's health requirements.
- 12. Dogs must be under the control of the handler at all times. Aggressive or uncontrollable dogs may be removed from the competition and the fairgrounds at management's discretion.
- 13. All contestants/owners/handlers must show proof of current vaccinations for their dog when entry form is submitted.
- 14. The Judges' decisions are FINAL.
- 15. First place winner agrees to appear with their dog for all media events required immediately following contest, including post contest interviews the evening immediately following the contest, and in New York on the first Monday following the contest. (*Travel costs for 1 owner and dog will be covered*.)

  - The Spirit Award is based on your dog's community service efforts. Please describe how your dog helps others (2-legged and 4-legged) in their community. Include why you and your dog selected this way of giving back to the community, the number of years that you have been doing this service, the number of "others" served, etc.

\*A dog cannot win this award in 2 consecutive years.

- Please include the following in your dog's BRIEF biography: Name, Age, Breed, Hometown, and State, how you acquired your dog, a few personality traits, and how many years you have entered this contest.
- Applications submitted after May 17, 2024, must include a \$10 entry fee. All entries submitted before May 17th are FREE. Entry Forms must be in our office by June 17th at 5 p.m. (Postmarks NOT accepted)

We hereby release all rights, title and interest in any photographs or video that may be taken by the management and/or designees.

# The first-place winner agrees to appear with their dog for all media events required immediately following the contest\*.

\*Directly following the contest, the winners will be interviewed by various members of the media and professional photographs will be taken.

\*The first-place winner will be asked to fly to New York on Sunday, June 23rd for an appearance on NBC's Today Show on Monday morning. Any interviews following the Today Show are at the discretion of the winner.

\*All dogs must have a health certificate (dated within 10 days of flying) and appropriately sized carrier. Dogs over 20 pounds are subject to special travel requirements.
